PRESENTATIONS

John P. Fish, from Commercial Utility Consultants and our representative as the lead agency in the South Shore Energy Aggregation Co-Op, provided an update on the auction results. Mr. Fish reported that there were 34 electric accounts in a 24 month contract with Verde Energy and 3 street lighting contracts with Constellation Energy and will result in an additional \$24,000.00 savings over a 24 month period. Mr. Fish stated that they went out to auction again, as well, and that savings is an additional \$13,779 for this year and \$15,979 for the second year. Mr. Fish reported that the South Shore Residential Aggregation Co-Op is moving a little slowly and is mainly due to the some issues Atlantic City Electric's Legal Department has with the contract verbiage; however, these issues should be settled very shortly. Mr. Fish reported that hopefully within the next week or so he will be able to report the auction date and provide those results.

WHEREAS, N.J.S.A. 40:8A-1 *et seq.*, authorizes municipalities and school districts to enter into agreements for the purposes of exchanging, sharing and cooperating with regard to services common to said communities through Interlocal Services Agreements ; and

WHEREAS, the Wildwood Catholic High School is in need of services relating to the use of recreational playing fields of the Borough of Stone Harbor for use by its High School sports teams (soccer and lacrosse); and

WHEREAS, the Borough of Stone Harbor has certain lands, equipment and personnel available to meet the needs of the Wildwood Catholic High School in this area; and

WHEREAS, entering into an Interlocal Services Agreement with the Wildwood Catholic High School for this purpose has been deemed to be in the best interests of citizens of the Borough and the students of the Wildwood Catholic High School; and

WHEREAS, in consideration of this Agreement and in an effort to supplement the costs of maintenance of Borough facilities, Wildwood Catholic agrees to pay the Borough the sum of \$1,500.00 per season.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Stone Harbor, County of Cape May, State of New Jersey that the preamble of this Resolution is hereby incorporated by reference;

BE IT FURTHER RESOLVED that the Borough of Stone Harbor and Wildwood Catholic High School hereby agree, under the authority of N.J.S.A. 40:8A-1 *et seq.*, as follows:

- 1. Wildwood Catholic High School agrees to pay the sum of \$1,500.00 per season per season and shall have full access to and use of the recreational ball fields of the Borough of Stone Harbor located in the vicinity of 80th Street and Second Avenue, for recreational activities officially sanctioned and conducted by the Wildwood Catholic High School and according to the schedules submitted.
- 2. Such access and use shall be conditioned upon coordination with and approval by the Recreation Director of the Borough of Stone Harbor with the understanding that the activities of the Borough of Stone Harbor Recreation Department take precedence.
- 3. The term of this Interlocal Services Agreement shall be from June 1, 2013 through May 31, 2014.
- 4. The Wildwood Catholic High School shall provide to the Borough of Stone Harbor written proof of liability insurance for the aforementioned use of the property of the Borough of Stone Harbor as required by the Atlantic County Joint Insurance Fund; and shall, additionally, hold harmless and indemnify the Borough of Stone Harbor for any and all loses, damages, and claims of whatever nature that may arise out of or in connection with the use of the property by the Wildwood Catholic High School, its sports/recreation participants, agents, contractors, officers and/or employees.

BE IT FURTHER RESOLVED that the Mayor and Clerk are hereby authorized and directed to execute this Resolution as the Interlocal Services Agreement between the Borough of Stone Harbor and the Wildwood Catholic High School, pursuant to N.J.S.A. 40:8A-1 *et seq*.

DISCUSSION:

Councilmember Kramar stated that all Councilmembers received in their Agenda packets a proposed Ordinance along with copies of photos of the proposed parking areas at the Borough Marina and along the Promenade between 80th and 83rd along First Avenue. Councilmember Kramar explained that the concept is for "parking by attendant permit" from 6:00 p.m. and 3:00 a.m. and these particular permits would be transferrable. Councilmember Kramar explained that at the Promenade there are 93 parking spaces and 50 spaces at the Marina which can be utilized which could possibly generate \$15,000 to \$25,000 in revenue for the Borough. Councilmember Kramar indicated that she consulted with Chief Reynolds on enforcement issues and he indicated he did not see any issues. After discussion amongst all Councilmembers, it was recommended that this Ordinance with some changes to include provisions for the Arts and Crafts Festival, etc. be placed on the next Agenda for introduction. Councilmember Kramar stated that there is a Public Works Committee meeting on Monday and if any Councilmember had any suggestions or concerns, they should e-mail her prior to the Monday meeting.

Mayor Walters stated that several business owners requested the use of free standing signs because their businesses were off the main street. Mayor Walters stated that the Planning Board formed a sub-committee who recommended an Ordinance which would allow a free standing sign if your business front door does not face a street, that business would be permitted a free-standing sign which would be regulated. Joanne Mascia, Zoning Official, described the regulations as follows: no more than one sign per property (one sign per mall regardless of the number of units in the mall); no sign shall exceed 3' in height nor 2' in width, but two-sided signs are permitted; they must be professionally made, and they can not be in the public right of way. Councilmembers discussed the proposed Ordinance and recommended that this Ordinance be returned to the Planning Board.

Mayor Walters stated that the Planning Board is recommending that Borough Council amend the Zoning Ordinance regarding "Limited Expansion of Non-conforming Structures without Variance Relief." Joanne Mascia stated that there is case law which states you cannot increase non-conforming structures and our Zoning Ordinance is very clear; however, the Board felt the wording should be amended to ensure the Ordinance could not be misinterpreted at all. Councilmembers discussed the Ordinance. Michael Donohue highlighted the case law on non-conforming structures and expanding upward, and within the footprint of a structure. Councilmembers recommended that this Ordinance be placed on the Agenda for the next Council meeting for introduction.

Work Session, June 4, 2013

Councilmember Rich provided an update on the beach replenishment project and reported that they are currently at 100th Street. Councilmember Rich reported that the company will be leaving and going to North Wildwood on Thursday, June 6, 2013 for a small project and then they will return to Stone Harbor to complete the project here. Councilmember Rich reported that weekly update meeting is tomorrow with the Army Corps of Engineers, DEP, and Stone Harbor officials, Public Works, etc. and more information will be available thereafter.

Councilmember Rich provided an update on the library. Councilmember Rich reported that

Deb Poillon, County Library Director; Marie McMahon, Facilities Director; Councilmembers Mastrangelo, Lane and herself; Jill Gougher; as well as members from both the Design Committee and the Programs Committee; and Kevin Settembrino, the Architect who was awarded the contract from the County, met last Friday. Councilmember Rich stated she is very excited about the library and she believes we have assembled an excellent team. Councilmember Lane stated that the County has purchased an e-mail program and urged everyone to go to the Library to sign up to receive e-mails for all updates on the County Library. Councilmember Lane reported that she will be giving a Library update at the ROA meeting on Saturday morning as well as a Water Conservation presentation.

Councilmember Lane reported that the Water Conservation Ordinance is not on the Agenda this evening because it is not exactly what we want so it is going back to Committee for revisions which meet on June 17, 2013 which Michael Donohue will be attending. Councilmember Lane stated that this Ordinance will be on the Agenda for introduction at the next Council meeting.
