ORDINANCE 1434

An Ordinance Amending Chapter 570 of the Revised General Ordinances of the Borough of Stone Harbor 2006, (Revising the Reference to the Zoning Map and Changing the Zoning District Classification for Certain Parcels within the Borough of Stone Harbor)

Section 1. Section 570-6 is hereby amended as follows:

"The districts and their boundaries shall be as shown on the Zoning Map, dated June 1, 2006, together with approved revisions, and prepared by Remington, Vernick and Walberg Engineers, on file in the office of the Administrative Officer, hereinafter to be referred to as the "Zoning Map of the Borough of Stone Harbor.""

Section 2. The Borough of Stone Harbor, under the authority of N.JS.A. 40:55D-62, *et seq.*, in the interests of the health, safety and welfare of the citizens of the Borough of Stone Harbor and in order to effectuate the public purposes of the Borough of Stone Harbor, hereby amends the district designations for the following lots:

Lots	Block	Existing Designation	New Designation
71, 72, 73 74, 75, 76 77 & 78	93.03	Business District (BD)	Public Use (PU)
67 & 69	95.02	Business District (BD)	Public Use (PU)

Section 3. This Ordinance shall take effect immediately upon final passage and publication in accordance with the law and the appropriate revision of the Zoning Map, which is hereby authorized.

Section 4. The provisions of this Ordinance shall be severable. In the event that any portion of this Ordinance is found to be invalid for any reason by any Court of competent jurisdiction, such judgment shall be limited in its effect only to the portion of the Ordinance actually adjudged invalid and shall not be deemed to affect the operation of any other portion thereof, which shall remain in full force and effect.

Section 5. All other Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistencies.

ORDINANCE

AN ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION OF \$ 71,250 FOR THE PREPARATION AND EXECUTION OF APPROVED TAX MAPS IN THE BOROUGH OF STONE HARBOR, IN THE COUNTY OF CAPE MAY, NEW JERSEY, FOR THE USE OF THE LOCAL ASSESSOR OF THE BOROUGH.

WHEREAS, the Local Budget Law of the State of New Jersey allows for a special financing mechanism for local governmental units to obtain an appropriation to cover the costs of tax revaluations; reassessments and/or revisions to the local Tax Map; and

WHEREAS, the applicable statute defines such financing as a "Special Emergency Appropriation" and requires the adoption of a special ordinance in order to authorize such financing; and

WHEREAS, the Borough of Stone Harbor is required to make a period revision of the Tax Map prior to the completion of any program of reassessment or revaluation, and the time has come to complete such revisions to the Tax Map;

NOW, THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF STONE HARBOR, IN THE COUNTY OF CAPE MAY, NEW JERSEY, AS FOLLOWS:

Section 1. A special emergency appropriation in the amount of \$71,250 is hereby authorized and made for the purpose of the preparation and execution approved tax maps in The Borough of Stone Harbor, New Jersey (the "Borough") for the use of the local assessor of the Borough.

Section 2. The Borough is hereby authorized to finance such appropriation from surplus funds available or by issuing special emergency notes from time to time in accordance with the provisions of N.J.S.A. 40A:4-55, all as shall be determined by and pursuant to a resolution or resolutions of the Borough to be hereafter adopted.

Section 3. In accordance with the requirements of N.J.S.A. 40A:4-53, a copy of this ordinance as adopted shall be filed with the Director of Local Government Services in the Department of Community Affairs of the State of New Jersey.

Section 4. This ordinance shall take effect after publication after final adoption, as provided by law.

Wildlife will also be removed by live trapping on resident's property. All applicable state laws will be followed in dealing with wildlife, including arranging for rabies testing through the Dept. Of Health.

ORDINANCE NO.

AN ORDINANCE AMENDING CHAPTER 300 OF THE REVISED GENERAL ORDINANACES OF THE BOROUGH OF STONE HARBOR AND REGULATING CONSTRUCTION IN "V" ZONES

WHEREAS, the Code of the Borough of Stone Harbor (the "Code"), at Chapter 300 (the "Flood Damage Protection Ordinance"), establishes regulations for flood damage protection within the Borough of Stone Harbor (the "Borough"); and

WHEREAS, recent amendments to the Best Available Flood Hazard Data issued by the Federal Emergency Management Agency ("FEMA") have altered the minimum base flood elevations in the Borough and resulted in a number of lots within the Borough being located within zones identified as V1-30, VE or V on the Borough's Flood Insurance Rate Map ("FIRM"); and

WHEREAS, the Borough Council (the "Council") desires to implement changes to the Flood Damage Protection Ordinance in order to secure safety form flood, provide for the health, safety and welfare of its citizens, and promote a desirable visual environment through creative development techniques, and

WHEREAS, the Council has determined the amendments set forth below achieve such purposes by requiring structures in the "V" zones to incorporate the use of breakaway walls or other barriers below the lowest floor in compliance with federal regulations.

NOW, THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Stone Harbor, Cape May County, New Jersey, as follows:

- **Section 1.** Code Section 300-15(B)(4) is deleted in its entirety and replaced with the following:
- (4) Space Below Lowest Floor. All new construction and substantial improvements shall have the space below the lowest floor constructed with non-supporting breakaway walls, open wood lattice-work, or insect screening intended to collapse under wind and water loads without causing collapse, displacement or other structural damage to the elevated portion of the building supporting foundation system. Breakaway walls shall comply with the requirements of 44 C.F.R. 60.3(e)(5) or any successor federal regulation. Such enclosed space shall be usable solely for parking of vehicles, building access, or storage and shall be subject to existing zoning regulations including, without limitation, the definition of "Story" set forth in §560-10.
- **Section 2.** If any portion of this ordinance is determined to be invalid by a Court of competent jurisdiction, that determination shall have no effect upon the remainder of this Ordinance, which shall remain valid and operable.
- Section 3. All ordinances or parts of ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, be and the same are hereby repealed.
- **Section 4.** This Ordinance shall take effect twenty (20) days after final passage and publication as provided by law.
