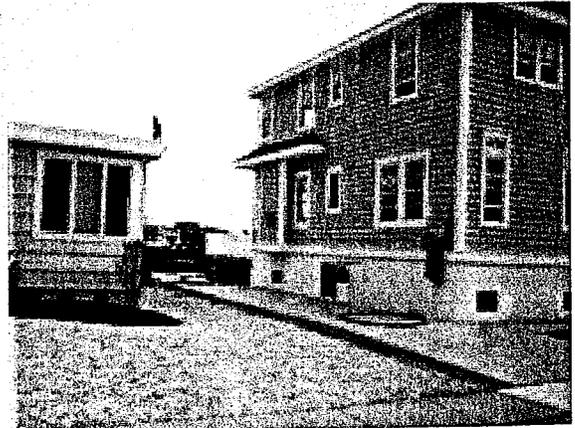
FRONT VIEW
