Mayor Davies-Dunhour announced that the meeting was now open. Adequate notice of the meeting was provided by posting a copy of the time and place on the Municipal Clerk's bulletin board and mailing a copy of same to the Atlantic City Press and the Cape May County Herald on February 7, 2023.

SALUTE TO THE FLAG

Mayor Davies-Dunhour made the following statement:

Before we get started, I would like to say a few things about process and procedure. You have before you a resolution to go into closed session to discuss a personnel matter. It is my understanding that it is the intention of several council members to not move this resolution forward OR to vote it down and to instead simply take action on this matter without discussion.

To clarify, it is my understanding that it is the intention of members of this council to make a monumental decision that has ramifications for not only the Borough of Stone Harbor but for an individual employee without any discussion or debate among the entire governing body. A decision that has a cost of \$48,157.87 to the taxpayer. How did we get here? Why are we not following our usual process and procedure and requiring discussion and deliberation before asking the taxpayer for close to \$50,000.

What is the plan? Where are we going? What promises have been made? Clearly there has been discussions taking place among council members. Clearly these discussions are fractured and not inclusive of the entire governing body. What are they? They are discussions taking place behind closed doors in a "cloak and dagger fashion" complete with veiled threats. It is back door, non-transparent, dirty government. It is the worst sort of politics. This is why people despise elected officials. This is not our process in Stone Harbor and has not been our process for the six years I have sat in this chair. This is not good government. I thought in Stone Harbor we strive to practice good government.

If, after fact finding, discussion, debate and deliberation, a majority of the council vote to move in a certain direction I will, of course, respect that process and the subsequent decision. That is good government.

So, I am appealing to your sense of reasonableness and asking you to respect our taxpayers and to do what is right and practice good government. I am asking you to pass this resolution, go into executive session and begin a process that is inclusive and in the best interest of Stone Harbor.

RESOLUTION 2023-S-60 — A Resolution Providing for a Meeting Not Open to the Public In Accordance with the Provisions of the New Jersey Open Public Meetings Act NJSA 10:4-6 "Personnel"

WHEREAS, it is necessary for the Borough Council of the Borough of Stone Harbor to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4–12b and designated below:

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Stone Harbor, assembled in public session on February 9, 2023 that an Executive Session closed to the public shall be held on February 9, 2023 at or about 4:30 P.M. in the Borough Hall of the Borough of Stone Harbor, 9508 Second Avenue, Stone Harbor, New Jersey, for the discussion of matters relating to the specific items designated above.

Official action may be taken as a result of said executive session.

It is anticipated that, in accordance with law and in a timely manner, the deliberations conducted in closed session may be disclosed to the public upon the determination of the Borough Council that the public interest will no longer be served by such confidentiality.

WHEREAS, pursuant to <u>N.J.S.A</u>. 40A:9-138, the Borough Administrator may be removed <u>without</u> cause by a 2/3 vote of the governing body; and

WHEREAS, the statute provides that removal may be effective immediately, and

WHEREAS, if effective immediately, the governing body shall cause the administrator to be paid forthwith any unpaid balance of their salary and their salary for the next three (3) calendar months following the adoption of the resolution; and

BE IT RESOLVED by the Borough Council of the Borough of Stone Harbor to remove Robert Smith from the position of Borough Administrator, in accordance with N.J.S.A. 40A:9-138, effective immediately.

BE IT FURTHER RESOLVED, by the Borough Council of the Borough of Stone Harbor that Robert Smith shall be paid his salary for the next three (3) calendar months following the adoption of this resolution.

Mr. Smith thanked the Mayor and noted that she is one of the best Mayor's he has ever worked for. He wished everyone well.
