Mayor Davies-Dunhour announced that the meeting was now open. Adequate notice of the meeting was provided by posting a copy of the time and place on the Municipal Clerk's bulletin board and mailing a copy of same to the Press and the Cape May County Herald on January 4, 2023.

For the record this Council Meeting was held via Video/Telephone Conference in a Zoom format.

SALUTE TO THE FLAG

Recognition of Staff Sergeant Greg Jackson - Stone Harbor Police Department

Mayor Davies-Dunhour noted that Sergeant Jackson officially retired February 1, 2023 and recognized his family members present. Mayor Davies-Dunhour thanked Sgt. Jackson's family for their support to his career. Sgt. Jackson started his career at the Stone Harbor Police Department in 1998 as a SLEO II Officer at 19 years old. While training in the Police Academy Sgt. Jackson received academic award, 1st place; firearms award, 1st place, physical fitness, 3rd place and received the Directors Award and was ranked number one is the graduating police officer course overall. Sgt. Jackson was a member of the Cape May County Swat Team and was promoted to Patrol Sergeant in June of 2009 and to Staff Sergeant June of 2022. He has received, in his career, 31 commendations and 51 letters of appreciation from residents. Throughout his career he received many Instructor certifications which include the following: Methods of Instruction, Defensive Tactics, Physical Fitness Instructor, Firearms Instructor, Patrol Rifle Instructor, Submachine Gun Instructor, Field Training Officer and Drill Instructor. Gregg played a major role in the Cape May County Police Academy.

Mayor Davies-Dunhour and Council presented Staff Sergeant Greg Jackson with a Plaque for his years of service and thanked him for his time as a Stone Harbor Police Officer.

Dock Hearings:

Lauren Plasket from Channel Marine was sworn in by Solicitor Karavan.

10907 Sunset Drive: Fischer. New Structure, DEP approved.

Councilmember Parzych asked if the CAFRA permit has been received. Ms. Plasket acknowledged that the CAFRA permit has been received. Councilmember Parzych further asked if the proposed dock extended out into the water further than the prior dock. Ms. Plasket explained that the drawing presented are approximately one foot and a half further than existing dock but still not as far as the neighboring docks. Ms. Plasket confirmed that there is no boat lift within the plans for this dock.

Public Hearing for 10907 Sunset Drive was opened.

No one came forth either in person or on zoom.

Public Hearing for 10907 Sunset Drive was closed.

Motion to approve the dock application at 10907 Sunset Drive was made by Councilmember Dallahan and seconded by Councilmember Foschini.

387 83rd **Street Petrick, reconfiguration approved by the NJDEP:** Solicitor Karavan clarified that the dock application presented to council included the addition of a boat lift. Ms. Plasket confirmed that this application has been amended to remove that request for a boat lift.

This dock is approximately one foot to one foot and half further out into the water. Ms. Plasket explained the drawing indicating that the dashed line is the existing dock (rectangular in shape) and that the solid line represents the proposed dock.

Ms. Plasket confirmed that this property is also reconstructing the bulkhead and has received proper permitting from the Borough. Ms. Plasket explained that the NJDEP allows a new bulkhead to be placed in front of existing bulkhead one times up to 24 inches. Borough Engineer Marc DeBlasio confirmed.

NJDEP Permits are handled through an environmental consultant and NJDEP could take six months to approve.

Public Hearing for 387 83rd Street was opened.

No one came forth either in person or on zoom.

Public Hearing for 387 83rd Street was closed.

Motion to approve the dock application at 387 83rd Street was made by Councilmember Dallahan and seconded by Councilmember Foschini. Solicitor Karavan noted that this application is being approved based on the amendment to remove the boat lift from the description received.

Dear Mr. Zukin,

Thank you for your email regarding the Council meeting of February 9, 2023.

I write in response to your email of February 10, 2023 regarding the Borough Council meeting of February 9, 2023. While I understand your displeasure with what you perceive as failure to take certain actions in compliance with "open government", a large part of that meeting's procedure was predicated by the requirements of New Jersey law.

Specifically, under the New Jersey Open Public Meetings Act, discussions involving local government personnel matters are by default are required to be conducted in private "closed sessions" outside the public purview. See the *N.J.S.A.* 10:4-12(b)(8). The main reason for this is to protect the employee's "personal privacy or guaranteed rights of individuals [which] would be clearly in danger of unwarranted invasion". *N.J.S.A.* 10:4-7.

However, there is an exception when the employee specifically requests that the meeting occur in open session. See, Rice v. Union Co. Reg. High School B.O.E., 155 N.J. Super. 64 (1977). Under Rice and the cases that followed it, when such personnel issues arise, the employee is given a written notice (called a Rice Notice) which allows the employee to request that the governing body discuss the personnel issue in open session. If the employee does not choose this option, any discussion must occur outside the public's purview in a "closed session".

Prior to the February 9, 2023, meeting you observed, the employee in question was provided a Rice Notice and did not ask for a discussion of his matter in open session. Based upon the same, Council legally could not discuss his personnel issue in open session. Council's actions that evening only amounted to foregoing a private closed session discussion (not open to the public) and to instead proceed directly with a public vote on the ultimate issue. I hope this better explains what occurred that evening.

HEARING OF THE PUBLIC ON MEMORIALS, RESOLUTIONS, PETITIONS & COMPLAINTS

Geoff Woolery: Speaking on Behalf of the Stone Harbor Property Association:

Speaking on the issue of NJDEP Permit process: Mr. Woolery offered assistance of the 1200 members of SHPOA to assist with putting pressure on the NJDEP to approve permitting needed ot pace lifeguard stands, concession etc. along our beachfront for 2023.

Ordinance/Resolution for Boat Slip Applications: Geoff noted that himself, along with a number of SHPOA trustees had a number of questions regarding the rules and regulations being proposed and thanked a number of council members who made themselves available to talk through concerns over this past weekend and appreciate their time to listen to comments and concerns. Mr. Woolery noted that there are proposed changes to the original Ordinance and Resolution as presented. Mr. Woolery felt concerned with an Ordinance and Resolution being presented simultaneously both presenting similar information, however there was different language which could be a concern. Mr. Woolery reminded the council of the legacy discussion at the last meeting and the "Right of First Refusal" language within the ordinance and is cautioning the council to be clear how this effects applications going forward.

Councilmember Parzych was under the impression that a letter was going to be included with the application which explained that the "legacy" is still being reviewed. The Borough Clerk stated that that is not the case. Councilmember Foschini stated that this matter of "Legacy" is still under review and will be further discussed in Committee.

Solicitor Karavan clarified the reasoning for approving an Ordinance and a Resolution for this process. He indicated the Resolution provides for an easier change to be made within the ordinance regarding rules and regulations and fees.

Joan Piotrowski: 256 98th Street; Invasive Species Ordinance: Ms. Piotrowski asked if the property next to your property and it spreads who would be responsible for removal. Councilmember Casper indicated that the Code Enforcement office would contact the property owner who has the invasive species and they would be provided with 45 days to correct the problem.

<u>Ordinance #1624</u> – Amending Chapter 174 of the Code of the Borough of Stone Harbor "Brush, Grass, Weeds, & Debris"

WHEREAS, the Borough Council has determined that it is in the best interest of the Borough to amend Section 174-3 of the Borough Code for clarity;

NOW THEREFORE, BE IT HEREBY ORDAINED by the Borough Council of the Borough of Stone Harbor, County of Cape May, State of New Jersey, that Chapter 174 of the Borough Code, titled Brush, Grass, Weeds & Debris" shall be amended as follows:

SECTION 1. Amend Language.

Amend Chapter 174 by deleting Section 3 in its entirety and replacing it with the following:

§ 174-3 Duty of owners and tenants.

It shall be unlawful for any owner or tenant, jointly and/or severally, of any land lying within the Borough, after receipt of the notice provided for in § 174-5 hereof, to permit and/or allow to exist, neglect or refuse to remove and destroy from any land any obnoxious growths such as brush, weeds of various types like ragweed, lawn grass in excess of 12 inches, dead or dying trees, stumps, roots, obnoxious growths of every description, filth, garbage, trash, rubbish and debris which may or does attract wild animals such as skunks, raccoons, possums or vermin and/or may create a risk to the health, safety or welfare of the public. It shall also be unlawful for any owner or tenant, jointly and/or severally, of any lands lying within the Borough, after receipt of the notice provided for in § 174-5 hereof, to permit and allow to exist, neglect or refuse to trim or remove any trees, the branches of which encroach into the public rights-of-way, or which interfere with the full use of such public rights-of-way.

SECTION 2. Severability and Effectiveness Clause

- a) If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.
- b) Any Ordinance inconsistent with the terms of this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION 3. Effective Date

This Ordinance shall take effect 20 days from the time of its final adoption and publication in accordance with law.

ORDINANCE 1625 - AN ORDINANCE AMENDING CHAPTER 156 OF THE GENERAL ORDINANCES OF THE BOROUGH OF STONE HARBOR GOVERNING BEACH RULES AND REGULATIONS

WHEREAS, the Borough Council adopted Resolution #2022-S-145 in July of 2022, which amended the rules and regulations governing conduct at paid beaches in response to concerns over increased boat landing(s), mooring(s) and swimming at the Point; and

WHEREAS, the provisions of the aforesaid Resolution have proved effective in advancing the Borough's efforts to establish appropriate control and regulation of the beachfront and the waters adjacent thereto for the health, safety and welfare of Borough residents and visitors; and

WHEREAS, Borough Council deems it to be in the best interest of the citizens of Stone Harbor to amend the within ordinance to permanently reflect the supplemental rules and regulations previously adopted by Resolution;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council, the Governing Body of the Borough of Stone Harbor, New Jersey as follows:

<u>Section 1.</u> Chapter 156-6(A) is hereby amended and supplemented to include paragraph 23, which shall read as follows:

"Access the beaches of the Borough of Stone Harbor from the ocean, bay, waterway or any other body of water adjacent to or abutting the beaches of the Borough of Stone Harbor by way of boat, whether power driven or otherwise, except as specifically provided for herein. Access to the beach(es) shall be in the manner and location(s) as set forth herein."

<u>Section 2.</u> Chapter 156-6(B) is hereby amended to include an additional sentence, which shall read as follows:

"The provisions and prohibitions of Chapter 156-6(A)(23) regarding boat access to the beach(es) shall be in effect year-round and are not subject to limited seasonal enforcement as is the case with the remainder of the beach rules and regulations."

<u>Section 3.</u> If any portion of this ordinance is determined to be invalid by a Court of competent jurisdiction, that determination shall have no effect upon the remainder of this Ordinance, which shall remain valid and operable.

<u>Section 4</u>. All Ordinances or parts of Ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, are hereby repealed.

Section 5. This Ordinance shall take effect immediately upon final passage and publication as provided by law.

<u>ORDINANCE 1626</u> - AMENDING CHAPTER 170 "BOATING" BY ESTABLISHING AN APPLICATION PROCESS FOR THE USE OF DOCK FACILITIES AT THE $81^{\rm ST}$ STREET MUNICPAL MARINA

WHEREAS, The Borough Clerks office is responsible for the application process for the use of dock facilities within the Borough of Stone Harbor; and

WHEREAS, the Borough Clerk's office is requesting that guidelines for the use of said dock facilities located at the 81st Street Marina be established; and

WHEREAS, guidelines for use of the 81st Street Marina Dock Facilities be determined to set rules and regulations, which may be established by resolution.

NOW THEREFORE BE IT RESOLVED that the following insertions be included within Chapter 170 "Boating" of the General Code of the Borough of Stone Harbor.

Section 1. Adding the following to Chapter 170-5

The permitting of seasonal boat slips will be administered through the Borough Clerk.

Section 2. Adding Chapter 170-7 Application Process – 81st Street Marina Boat Slips

§170-7 Application Process – 81ST Street Marina Boat Slips

Applications for use of the 81st Street marina boat slips will be processed through the Borough Clerk's Office. All season boat slip permittees shall be granted the first right of refusal to renew the slip occupied during the previous season. Renewal applications must be complete with payment in full and include an updated copy of a Certificate of Insurance in the amount of \$500,000 Liability Coverage which shall name the Borough of Stone Harbor as additional insured, proof of ownership and current registration. Failure to comply with Insurance requirements will result in forfeiture of the boat slip subject to the aforesaid renewal rights. Applications must be received by the date indicated on the renewal notice and if not received by the specified date it will be considered a forfeiture of the boat slip and the slip will be offered to individuals on the established 81st Street Marina Boat Slip waiting list, starting with the first person on said list.

Section 3. Adding Chapter 170-8 Violations

§170-8 Violations

Any applicant found in violation of the rules and regulations associated with the permitting of the boat slips at the 81st Street Marina shall be subject to forfeiture of their boat slip. There shall be no exceptions.

Section 4. If any portion of this ordinance is determined to be invalid by a Court of competent jurisdiction, that determination shall have no effect upon the remainder of this Ordinance, which shall remain valid and operable.

Section 5. All Ordinances or parts of Ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, be and the same are hereby repealed.

Section 6. This Ordinance shall take effect twenty (20) days after final passage and publication as provided by law.

ORDINANCE 1627 - AMENDING CHAPTER 365 "MARRIAGE AND CIVIL UNION CEREMONIES" BY ESTABLISHING FEES AND PROCEDURES FOR USE OF BEACHES AND PAVILIONS

WHEREAS, The Borough Clerks office is responsible for scheduling the use of beaches and pavilions within the Borough of Stone Harbor; and

WHEREAS, the Borough Clerk's office is requesting that a fee be established for the use of beaches and pavilions; and

WHEREAS, guidelines for use of beaches and pavilions be determined to set rules and regulations, which may be established by resolution.

NOW THEREFORE BE IT RESOLVED that the following insertion be included within Chapter 365 "Marriage and Civil Union Ceremonies" of the General Code of the Borough of Stone Harbor.

Section 1. Adding Chapter 365-4 Use of Beaches and Pavilions for Wedding Ceremonies

§ 365.4 Use of Beaches and Pavilions

Anyone whose wedding takes place on Borough property, limited to Beaches or Pavilions, shall be required to complete a permit application with the Borough Clerk and adhere to all Rules and Regulations regarding Use of Beaches and Pavilions, established by the Borough Clerk's office.

- A. Purpose: To provide guidelines and expectations to individuals that obtain the required permit for use of Beach or Pavilions within the Borough of Stone Harbor.
- B. Permit Application & Payment: Application must be completed and submitted to the Borough Clerk along with the appropriate fee. Approval is considered once the availability of location is determined.
- C. Insurance Requirement(s): All applicants are required to sign a Hold Harmless Agreement and provide the Borough of Stone Harbor with a certificate of Insurance indicating the continuation of insurance coverage and designating the Borough of Stone Harbor as an "Additional Insured". The policy must be current and not expire before or on the date of the event. The policy must provide insurance for no less than \$1,000,000. The Insurance Certificate provided must be in the name of the person applying for the beach/pavilion use.
- D. Fees collected: All fees collected by the Borough for the use of the Beach or Pavilion shall be remitted to the Borough of Stone Harbor. The fee for the permit shall be established from time to time by resolution of the governing body of the Borough of Stone Harbor.
- E. Cancellation: In the event of cancellation, for any reason, a non-refundable administrative fee of \$50 is required.
- F. Postponement: If any person needs to reschedule a ceremony, such postponement shall be permitted without additional cost. All postponements are subject to the availability of the requested location. Any changes to the original application must be received in writing by the applicant.
- **Section 2**. If any portion of this ordinance is determined to be invalid by a Court of competent jurisdiction, that determination shall have no effect upon the remainder of this Ordinance, which shall remain valid and operable.
- **Section 3**. All Ordinances or parts of Ordinances inconsistent with this Ordinance, to the extent of such inconsistencies only, be and the same are hereby repealed.

Section 4. This Ordinance shall take effect twenty (20) days after final passage and publication as provided by law.

- (2) The sale will be conducted online and the address of the auction site is govdeals.com.
- (3) The sale is being conducted pursuant to Local Finance Notice 2008-9.
- (4) A list of the surplus property to be sold is listed below.
- (5) The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.

RESOLUTION 2023-S-65 - A RESOLUTION PROVIDING RULES AND REGULATIONS PERTAINING TO THE PERMIT GUIDELINES FOR THE $81^{\rm ST}$ STREET MARINA BOAT SLIPS & ESTABLSIHING A FEE FOR THE 2023 SEASON

WHEREAS, the Borough Council of the Borough of Stone Harbor is authorized pursuant to Chapter 170-2 of the Revised General Ordinances of the Borough of Stone Harbor to establish rules and regulation essential to govern the use and manner of use of the facilities located at the 81st Street marina; and

WHEREAS, the following rules and regulations pertaining to the application process and use of marina boat slips are presented as follows:

- 1. The Borough Administrator, subject to the approval of Mayor and Council, is designated as the person in charge of and control of the operation and management of such facilities and is hereby empowered to assign any regularly employed person or persons of the Borough government to assist in the performance of any special duty or function relating to the 81st Street Marina Boat Slip facilities.
- 2. The season boat slips at the 81st Street Marina shall be issued to power vessels and sailcraft only.
- 3. A season permit fee shall be established by resolution and may, from time to time, be revised.
- 4. The permitting of marina boat slips will be administered through the Borough Clerk and be subject to the following rules and procedures:
 - a. All seasonal boat slip permittees shall be granted the first right of refusal to renew the slip occupied during the previous season. Proof of power vessel and sailcraft ownership with current registration is required. The owner of the power vessel or sailcraft must be the same name as the lessee.
 - b. Renewal applications, appropriate fee and required insurance certificate not received by the indicated date are subject to forfeiture.
 - c. The Certificate of Insurance in the amount of \$500,000 Liability coverage naming the Borough of Stone Harbor as an additional insured is required.
 - d. No refunds will be issued after 30 days of the issuance of seasonal boat slip permit.
 - e. The Borough Clerk shall maintain a waitlist for any persons interested in receiving a permit for a boat slip and any slips forfeited or not-renewed shall be offered to the waitlist, starting with the first person on the waiting list. Individuals who forfeit or fail to renew shall be required to re-apply to get onto the waiting list.
 - f. An updated application is required if any information on the original application should change.
 - g. Seasonal boat slip applicants and/or permittees shall not be permitted to assign or transfer their boat slip interest by any means or for any purpose whatsoever.
 - h. All permitted vessels must be emblazoned with up-to-date registration numbers/decals; and

WHEREAS, the Municipal Boat Slip Fee established by Resolution 2023-S-37 on January 3, 2023 be amended as follows:

\$2,100 Slips 9-25 \$1,900 Slips 26-79

- B. Use of the beach/pavilion is for no more than a 2-hour timeframe. This timeframe includes all deliveries, set up, ceremony and breakdown.
- C. Amplified sound is allowed provided it complies with the Boroughs noise ordinance.
- D. Decorations cannot attach to Borough's property.

RESTRICTIONS:

- E. No open flames, glass, alcohol, smoking, or fireworks are permitted.
- F. No lit lanterns or balloons are allowed to be used or released.
- G. No rice, birdseed, confetti, fake flower petals, or streamers are permitted due to environmental concerns.
- H. No Generators or motor vehicles are permitted on the beach.
- I. No portion of the public beach access, pathway or sidewalk shall be obstructed or utilized for the ceremony.

J. No Receptions on the public beach/pavilion, permit is for the ceremony only.

PARKING:

- K. Parking is metered from May 1st- October 1st 10am- 9pm. Parking spots are public and cannot be reserved or restricted.
- L. Public or private driveways shall not be blocked at any time.

<u>RESOLUTION 2023-S-67 -</u> ESTABLISHING EMERGENCY STONE HARBOR POINT BEACH ACCESS

WHEREAS, The Stone Harbor Borough Council declares a public safety emergency at the Stone Harbor Point Access Path. This path leads from the parking lot at 123rd Street, parallel to the oceanfront, and accessing the natural area known as Stone Harbor Point. This natural area has great importance to both residents and visitors, and state and Federal resource agencies. Due to the continued, repeated erosion of the vehicle access ramp, Stone Harbor Point is not presently accessible to police/fire/rescue equipment. The access has been closed, however people continue to access the Point. This leads to an unsafe condition if someone were to be injured. Additionally, the vertical scarp is greater than 6 feet increasing the risk of collapse or and individual falling.

WHEREAS, the initial erosion during the Mother's Day Storm in May 2022 caused the Borough to request an Emergency Authorization from the NJ Department of Environmental Protection, and expend resources to repair the ramp

WHEREAS, the remnants of Hurricane Ian in early October 2022 began to damage the vehicle access ramp, and a series of "king tides" occurred during mid-December of 2022 which completely destroyed the ramp causing the Borough to close the access,

WHEREAS, the Borough has requested an additional Emergency Authorization from the NJ Department of Environmental Protection on December 20, 2022 and has produced a set of drawings with the preferred repair alternative. The Borough and NJDEP continue negotiations pertaining to the issuance of an Emergency Authorization.

WHEREAS, continued erosion and flanking of the 127th Street groin further exacerbates the condition of the access point, and the Borough is planning for the return of visitors and residents in the spring, the likelihood of environmental impact due to the inability of police to monitor the area will increase, and the possibility of injury without adequate means of rescue also increase,

BE IT THEREFORE RESOLVED, that a public safety emergency exists at the Stone Harbor Point Access Path.
