### Water & Sewer

As the season begins, the use of water is starting to increase creating a need to make daily micro adjustments to our new disinfection system.

Repairs, replacements and new installs are completed as needed including the removal of any lead services.

Emergency generators are exercised monthly.

Daily flows are recorded daily from our wells and sanitary sewer lift stations.

We continue to test our water supply following the NJ State regulations and schedules.
