

**MINUTES OF THE REGULAR MEETING OF
MAYOR AND COUNCIL OF THE BOROUGH
OF STONE HARBOR HELD IN THE
MUNICIPAL BUILDING, APRIL 16, 2013**

The meeting was called to order by Mayor Walters at 4:30 p.m.

Mayor Walters announced that the meeting was now open. Adequate notice of the meeting was provided by posting a copy of the time and place on the Municipal Clerk's bulletin board and mailing a copy of same to the Press and the Cape May County Herald on January 4, 2013.

DOCK HEARING – 10032 Corinthian Drive, Block 200.03, Lots 462, 463, 464 and 465.01 – Rita M. DeLuca – Frank Bowen, President of Chanel Marine Construction

For the record, Mr. Donohue swore in Mr. Bowen on behalf of the property owner, Mrs. DeLuca. Mr. Bowen stated that he represents the property owner who applied to the Building Department to replace a "U" shaped floating dock with two 8' x 20' "U" sections and two access ramps. Mr. Bowen stated that the property owner has a Permit from the NJDEP and provided a copy of same to Mr. Donohue. (Copies were made for Mayor and Council). Councilmember Mastrangelo inquired how many boat slips would be going in. Mr. Bowen stated that normally two boat slips and probably two jet skies.

Mayor Walters asked if there was anyone in the audience to speak for or against the application.

Karen Zapf Hampel – 10038 Corinthian Drive -- read a letter on the record – and objected to the request. Ms. Hampel stated that this property is a vacant lot which is not maintained and never has been maintained. Ms. Hampel stated that the property owner is trying to turn this lot into a commercial business and make it a yacht club (at least 8 boat slips) with not enough parking which will create a lot of pollution, a dangerous situation for the young residential swimmers, and other objectionable activity.

Eric Zapf – 10001 Sunrise – expressed his concern because he is a boater but mostly because when he walks past his property which he has done so for the past four years, the neglect and the filth is astonishing. Mr. Zapf stated that he grew here in Stone Harbor and we already have three commercial basins and the rumor is that Mr. DeLuca is going to put in 8 boat slips for rent. Mr. Zapf stated that even worst would be the jet skies. Mr. Zapf stated that before a marina is approved, the house should be built first. Mr. Zapf provided Council with pictures of the property and objected to the application.

Randy Binter – 10039 Corinthian – stated that this property has never been maintained. Mr. Binter stated that the property needs to have a house built on it before it can have a dock. Mr. Binter stated that the added pollution and traffic will be a detriment to the neighborhood and objected to the dock hearing.

Elmer Tate – 401 Charles Street – stated that the property has no home on it and has never been maintained and currently has many safety and health issues and when the marina is added, it will just contribute to an already existing hazard. Mr. Tate stated that there will be port-o-potties, crime, trash cans, danger to the swimmers and many other hazards. Mr. Tate stated that this property needs a home first, not a commercial marina with 8 boat slips. Mr. Tate also asked about all of the illegal discharge coming out of the boats, the oil coming out of the pumps and who is going to keep an eye on that. Mr. Tate also inquired about the size of the boats permitted. Mr. Tate requested that the request be denied until the property owner builds a home on his property.

Bunny Parzych – inquired how many boat slips are being requested and stated that the rumor is that the request is for a commercial marina. Mrs. Parzych stated that the property has been for sale for

many years. Councilmember Mastrangelo advised Mrs. Parzych that the CAFRA Permit specifically states no more than four (4) motorized vessels may be moored at this location at any time. Mrs. Parzych inquired about jet skies. Councilmember Mastrangelo responded that jet skies are considered a motorized vessel. Mrs. Parzych stated that this seems like an auxiliary use for the property and the main use of the property would be a residential home. Mrs. Parzych stated that the neighborhood is very upset.

Mr. Bowen outlined the proposed project which would be to construct the main dock (36' x 6' "U" shaped floating dock) with two 8' x 20' "U" shaped sections and two access ramps on each side and stated you could never have a boat that would reach the property line.

Mr. Elmer disagreed with Mr. Bowen and stated that a 40' Viking would reach the property line.

Gil Lacciteiello – 10033 Corinthian – inquired how the Borough is allowing a marina/commercial situation in a residential area. Mayor Walters responded that the request is for a dock on a residential property not for a commercial marina, and the request says nothing about operating a business or marina. Mr. Donohue inquired if Mr. Lacciteiello knew of anything specific because the request before Mayor and Council is for a residential dock for four (4) boat slips and nothing else. Mr. Lacciteiello responded that no it was just hearsay. Mr. Lacciteiello stated that the property is never taken care of and he is concerned that this commercial activity will increase the trash and the neglect of the property.

Mr. Bowen suggested that this hearing be continued and that he bring his client to the next meeting so that they can be here to address these issues.

Mayor Walters stated that there is a policy and procedure in place when a property owner fails to maintain his property.

Mayor Walters closed the public portion of the meeting

Mr. Donohue explained to the public that the Department of Environmental Protection (DEP) has exclusive jurisdiction over these types of questions and complaints. The DEP grants the approval for the permit and the configuration for construction of the dock itself, not the Borough Council. Mr. Donohue explained that the issues regarding the length, the number of boats moored at the dock, etc., are not issues that Borough Council can vote on, even if they wanted to. Mr. Donohue explained that the only issue before Borough Council is if the dock to be constructed extends beyond the exterior property line as shown on the official tax map and if it does, then the Zoning and/or Construction Officer sends the applicant to Borough Council for a hearing to get approval to go beyond the property line. Mr. Donohue stated that that is all that this hearing today is about, i.e., is there any reason not to allow this construction beyond the property line. Mr. Donohue stated that the Council has no other authority regarding this permit. Mr. Donohue stated that Chapter 174 of the Revised General Ordinances of the Borough provides for Brush, Grass, Weeds and Debris wherein the Borough can notice a property owner and advise them to trim or remove and destroy and if they fail to do so in a timely manner, the Borough will do the work, issue an invoice and/or issue a lien on the property. Mr. Donohue suggested that this may be the proper course of action concerning the complaints heard this evening. Mr. Donohue stated that some of the other issues raised this evening like port-o-potties are zoning issues and would have to be addressed by Zoning if and when port-o-potties were placed on the property. Mr. Donohue stated that if more than four (4) boats were moored at the dock, then the DEP would need to be contacted.

It was noted for the record that the DEP permit was issued on June 10, 2009 and the expiration date is June 10, 2014.

Grant Russ, Safety Coordinator, and other members of the Borough's Safety Committee including Councilmember Mastrangelo, Jill Gougher, Kim Stevenson, and Suzanne Stanford presented the Chief of Police, Paul Reynolds, with new medical bags equipped with oxygen and other essential first aid supplies. Mr. Russ explained that as a result of the Borough's proactive safety policy, the JIF rewarded the Borough with a \$1,500 safety incentive which was used to purchase new first responder medical bags, one for each of the six police patrol vehicles. Chief Reynolds expressed his appreciation for the medical bags and stated that they will help officers manage situations until paramedics arrive at a scene.

Since all members of Council have been provided with a copy of the minutes of the Regular Meeting of March 19, 2013 and the Work Session Meeting of April 2, 2013 if there are no additions or corrections, I move we dispense with the reading of the minutes and that they be approved.

PUBLIC SAFETY – Councilmember Carusi reported that the Public Safety Committee met on April 15. Councilmember Carusi explained that the Public Safety Committee is comprised of Fire, Police EMS, Courts, and OEM. Councilmember Carusi reported that the Committee discussed the following issues: the installation of new recording equipment, the hiring of personnel for the months of May through October to serve as a Violations Clerk, purchase of a Stricker Stretcher, updated OEM Procedure Book, Registration for Storm Damage has been extended to May 1, filed with FEMA for storm damages for approximately \$200,000, and the hiring of 3 Class I SLEOs. Councilmember Carusi reported that the meeting with the State regarding a shared services agreement with Avalon for dispatch was postponed and has not yet been rescheduled because the State is awaiting additional information from Avalon. Chief Reynolds provided the police statistical report for March, 2013 as follows: 733 incidents logged, 9,770 miles patrolled; 103 motor vehicle stops; 17 moving violations; 2 parking violation; 0 motorists assisted; 0 accidents handled; 4 suspicious motor vehicles; 5 adult arrests; 0 driving while intoxicated; 4 alarms; 9 fire calls; 6 EMS; 49 open doors/windows; 4 heater lights; and 9 animal complaints. Chief Reynolds reported on training for the police department and dispatchers and a recent arrest for burglary and criminal mischief and provided an update from an arrest made in November 2012, as well as one thank you note was received. Chief Reynolds personally thanked Grant Russ, Jim Nicola, and Sgt. Chris Palmer for their work on the Safety Committee.

NATURAL RESOURCES - Councilmember Rich reported that the beach replenishment project is ready to begin and the Borough will receive approximately 420,000 cubic yards of sand and meetings on the replenishment are held weekly. Councilmember Rich reported that the Natural Resources Committee researched the idea of planting beach plums along the beaches in the future and the USACE recommends planting beach plums as a conservation plan in preventing erosion and building stabilization as well as a windbreaker. Councilmember Rich reminded everyone about the Beach Sweep on Saturday morning, April 27th at the 96th Street Beach from 9:30 a.m. til noon. Councilmember Rich also reported that fencing and signs have been installed at Stone Harbor Point, the Committee is waiting for the Boat Owners' Association to return the Memorandum of Understanding regarding Site 103, the Mayor, Michael, Jill and she met to discuss dredging and how to move this project forward and Remington Vernick will be helping to gather information. Councilmember Rich reported that she attended a second meeting regarding waterway debris removal and the project manager informed us of the progress they are making on the removal of floating debris, submerged debris, and sediment debris and explained the entire process. The project manager reported that they will be coming to Stone Harbor and people should report any type of visible debris (docks, wood, etc.) to Jill Gougher as soon as possible. Councilmember Rich reported that the NJDEP Office of Engineering and Construction discussed the Advisory Base Flood Elevation maps and the beach replenishment and the dunes at this meeting as well. Councilmember Rich reported that

she had an opportunity to meet the Borough's Regional Manager, Tim Berkhimer. Councilmember Rich reported that the Department of Corrections worked in the Bird Sanctuary on April 2nd, 3rd, and 4th to remove invasive plants on the Moonscape and remove some other storm debris, the Bird Sanctuary Committee met on April 12, 2013 and discussed future plans, worked on finalizing the Duffield contract, and developing a Bench Cleaning Plan for the 40-50 benches in the Bird Sanctuary. Councilmember Rich reported that the Natural Resources Advisory Committee is planning to meet next month to make and set goals.

Councilmember Rich reported that the Planning Board met on April 8, 2013 and seven members were present. Councilmember Rich reported that the members discussed the Waterfront Business District Committee and why this committee was formed; however, the Committee has had only had one meeting thus far and did not have anything substantive to report. Councilmember Rich reported that at the April 22nd meeting, a minor subdivision application is scheduled.

BEACH & RECREATION – Councilmember Davies-Dunhour reported that the Beach, Recreation and Tourism Committee is scheduled to meet on April 19, 2013. Councilmember Davies-Dunhour reported that on Friday, April 12, 2013, Councilmember Rich, representatives from Public Works, Jill Gougher, and she met with the Chamber of Commerce Executive Board to discuss upcoming events and to clarify what role each will take in order to increase promotion and insure greater success. Councilmember Davies-Dunhour reported that beach tag sales are up almost \$6,000 from this time last year. Councilmember Davies-Dunhour reported that beach tags are available Monday through Friday at Borough Hall and on the weekends at the Chamber of Commerce. Councilmember Davies-Dunhour reported that the bid for the Beach Concession stands has been awarded and the stands are at the 80th Street Marina for Public Works to do some repair work on them and they will be on the beach for Memorial Day Weekend. Councilmember Davies-Dunhour reported the Recreation Department is getting ready for the summer season with a full complement of camps. Councilmember Davies-Dunhour reported that the Borough-wide mailing was mailed last month and included in the mailing was the early Registration Form for Stone Harbor property owners to register their children for Recreation Programs. Councilmember Davies-Dunhour reported on a new fitness program, Wellness and Weight Loss, which is a 4 week program (2 days per week) for only 12 people (which is sold out) and is being conducted by Betsy Markle of Sunshine Wellness. Councilmember Davies-Dunhour stated that since this program was so successful and sold out so quickly we are hoping to try and schedule another 4 week program. Councilmember Davies-Dunhour reported that on May 4th and 5th the Borough will host its first Art & Music Celebration featuring new music acts that the Tourism Direction found at the Singer Songwriter Convention in Cape May as well as artists from a co-op and showcasing our local art galleries on the nodes and shops as well. Councilmember Davies-Dunhour reported that there will be a map which identifies where each featured artist/musician is located. Councilmember Davies-Dunhour reported that information regarding the jitney service is now available on the Borough's website.

UTILITIES - Councilmember Lane reported that work on the ordinances has been postponed because Grant Russ has been on vacation. Councilmember Lane reported that work on the water tower is approximately 6 weeks behind schedule, but it should be completed by June. Councilmember Lane reported that a meeting was held with the plumbing and construction officials to try and clarify the responsibilities of the construction office and the plumbing inspector; a review of the ordinances has indicated that the plumbing inspector is aware of his obligations. Councilmember Lane reported that a notice outlining ordinances will be included in the Construction Permit Jacket. Councilmember Lane reported that the second quarter readings have been completed and approximately 3.7 million gallons of water have possibly been lost since January. Councilmember Lane stated that there is a resolution on the Agenda this evening regarding water exemptions for certain charitable organizations which has been an ongoing issue; however, good intentions are not always good government and it is always easy to give something away and it is always very difficult to take it back. Councilmember Lane stated that the decision to bill these local charitable organizations for water was not done out of vindictiveness, but was for a fee for service and the Committee felt they were acting fiscally responsible and with good management. Councilmember Lane stated that the majority of Council does not agree, so there is a Resolution on tonight's Agenda exempting water and excess water charges for the local charitable organizations, but they will receive bills so they know their usage. Councilmember Lane urged these organizations to conserve their water. Councilmember Lane reported the water diversion this month was down 259,000 from this time last year. Councilmember

Lane reported that the Go Green Committee met and discussed the upcoming Paper Shredding Day on May 18, 2013, the same day as the Garden Club's Yard Sale and the application to become "Sustainable NJ Certification" which will allow the Borough to apply for and be eligible for a lot of

grants as well as improve our image with the DEP.

Councilmember Lane reported that the bank building should be demolished before May 22, 2013. Councilmember Lane reported that she and Councilmember Rich spoke to Freeholder Marie Hayes to schedule a meeting with each of the Library Committees.

PUBLIC WORKS – Councilmember Kramar apologized for being late to arrive to the meeting but she got off a plane at 2:30 p.m. in Philadelphia and did her best to get here in a timely fashion. Councilmember Kramar reported that all the Borough grounds are being landscaped for spring/summer; all playgrounds are being checked and prepped, cross-overs have been repaired and split rail fence and sand fence has been installed; docks have been repaired or rebuilt; the 95th Comfort Station has received two coats of gel painting to the floor; installing new electrical services to the beach concession stands as well as making small repairs to the stands; Special Events required 3.5 man-hours. Councilmember Kramar offered kudos to Grant Russ and the Safety Committee for the JIF Safety Incentive Award. Councilmember Kramar reported that the tipping fees for March, 2013 were \$11,687.30 compared to \$3,915.56 in March of 2012. Councilmember Kramar reported that 39 bags of litter were collected during the month of March and the first Bulk Trash Day generated four trips to the MUA with 23.15 tons for a savings of \$1,556.85. Councilmember Kramar reported that next Bulk Trash Day is Monday, May 6, 2013. Councilmember Kramar reminded everyone that the Single Stream Recycling started April 1, 2013.

ADMINISTRATIVE & FINANCE – Councilmember Mastrangelo reported that the A & F Committee met on April 1, 2013 and a review of the March revenue reports show that we have collected \$558,296.45 for 2013 while we collected \$600,663.95 in 2012 and we also continue to see an increase in revenue for Uniform Construction fees and beach tag revenue. Councilmember Mastrangelo reported that Glen Ortman, the Borough's Auditor, met with A & F to conduct an Exit Conference on the Borough's Audit which had No Findings. Councilmember Mastrangelo thanked Jim Nicola and Patti Wagner and the various departments for a job well done. Councilmember Mastrangelo reported that the 2012 Audit will be available on the webpage shortly; Councilmember Mastrangelo reported that the Borough is the Lead Agency in the Energy Aggregation Program in South Jersey and the towns currently participating are Wildwood, Middle Township and Commercial Township. Councilmember Mastrangelo reported that we are expecting significant savings which could start as early as June 1, 2013. Councilmember Mastrangelo reported that the Borough held a public hearing earlier today for residents which was well attended. Councilmember Mastrangelo reported that an energy auction will be held by Commercial Utility Consultants on behalf of the municipalities and the successful bidder will get a one-year contract, there are no hidden fees or cancellation charges and you can opt out at any time. Councilmember Mastrangelo reported that more information regarding the program is available on the Borough's website. Councilmember Mastrangelo reported that he has attended additional meetings on the new FEMA maps and the Borough continues to work with other local municipalities, State and Federal legislators and their staff members and professionals to insure amendments to the preliminary maps are done so that they more accurately reflect the actual risks.

Jill Gougher reported that the DCA is waiting for information from the Borough of Avalon before scheduling a meeting to discuss and/or recommend the consolidation and/or shared services agreement for dispatching services. Mrs. Gougher reported that she and Mr. Pepper met today with union representatives and the negotiations went very good and she is optimistic that she will have a recommendation for the next Council meeting. Mrs. Gougher reported that she and Liz Hargett are reviewing three proposals that were submitted for the Borough's website. Mrs. Gougher also thanked Jim Nicola and Patti Wagner and all the departments for another job well done on the 2012 Audit.

ENGINEER'S REPORT - Mark DeBlasio, Borough Engineer, provided the Engineer's report as follows:

Beach Outfall Elimination Project – Phase 2

- Contractor is continuing work on First Avenue improvements.

- 92nd Street, 93rd Street to 98th Street infrastructure, concrete and base paving is complete
- Contractor is currently top paving all streets.

NJDEP Water Allocation Permit

- We have completed the water allocation permit application forms and are coordinating signatures and permit fees. The NJDEP will not require the Borough to submit for permit renewal in addition to the application being filed.
- Because of Hurricane sandy, NJDEP was delayed in providing the well search data we requested. The data is now received and is being input into the require GIS maps. With this delay we anticipate submitting the application with the completed hydrogeologic report by mid-January.

USDA Rural Business Enterprise Grant (RBEG) Application

- The Borough was denied grant funding for planning and streetscape improvements.
- However, the application can be re-submitted to USDA for FY 2013.

95th Street Water Tank Improvements and Repainting

- The bid opening was held on December 13, 2012 and the apparent low bidder is Corrosion Control Corporation in the amount of \$484,200.00
- A pre-construction meeting was held on January 24, 2013.
- The blasting equipment has been delivered to the site.
- Interior painting repairs have begun.
- Exterior painting will begin this week.

95th Street Well Redevelopment

- The bid opening occurred on February 7, 2013.
- Uni-Tech Drilling was awarded the contract in the amount of \$112,900.00.
- A pre-construction meeting has been scheduled for March 21, 2013 at 1:30 PM.

Beach Concession Stand

- We have received a notification from the NJDEP that a CAFRA permit is not needed for the Borough's beach concession stands.
- Bid documents have been revised and the project has been re-advertised with the bid opening scheduled for March 26, 2013 at 10:00 AM.
- The contract has been awarded to Atlantic Ice Cream, LLC in the amount of \$124,464.00 for a two year total.

Ocean Sport Rental Concession and Hobie Cat Rides

- The project has been re-advertised with no changes to the bid documents.
- The new bid opening is scheduled for April 25, 2013 at 10:00 AM.

9/11 Memorial Park

- We have completed the survey and base mapping for the project.
- We have been authorized to complete bid documents and the design is approximately 60% complete.
- We have completed the Cape May County Open Space Application.

FEMA Hazard Mitigation Grant Program

- This grant program provides a 75% grant for various flood mitigation projects.
- The Borough has selected to submit five (5) grant applications and the first step is to submit a Letter of Intent for each project by March 31, 2013.
- The five (5) applications are as follows:
 - Replacement of Various Bulkheads
 - Raising of Various Private Homes
 - 111th Street Beach Outfall
 - Emergency Generators at Recreation Building
 - Various Pump Station Elevation Adjustments

RESOLUTION OF THE BOROUGH OF STONE HARBOR AUTHORIZING THE ESTABLISHMENT OF A COOPERATIVE PRICING SYSTEM AND TO ENTER INTO COOPERATIVE PRICING AGREEMENTS WITH OTHER CONTRACTING UNITS

WHEREAS, *N.J.S.A. 40A:11-11(5)* authorizes two or more contracting units to establish a Cooperative Pricing System and to enter into a Cooperative Pricing Agreement for its administration; and

WHEREAS, the Borough of Stone Harbor is desirous of establishing a Cooperative Pricing System and entering into a Cooperative Pricing Agreement with other contracting units;

WHEREAS, the Borough of Stone Harbor has agreed to serve as the Lead Agency for a Cooperative Pricing System; and

WHEREAS, the Borough Council of the Borough of Stone Harbor has duly considered the establishment of a Cooperative Pricing System for the provision and performance of goods and services; and

NOW, THEREFORE BE IT RESOLVED as follows:

Additionally, the lifeguard captain, or his designated assistant, shall have the right during operations on a daily basis to move each bathing beach up to one-half block in either direction in order to take advantage of the best local conditions at the beach site. The lifeguard captain or his designated assistant, may also close a beach due to adverse weather conditions or lack of personnel, or for any other appropriate reason.

BE IT FURTHER RESOLVED that the use of surfboards (with leashes attached) shall be permitted at the beaches at 81st Street and 110th Street only, and all surfers shall be required to comply with the directions of the lifeguards based upon local conditions at the time. DOCTRINE OF NECESSITY

Mr. Donohue explained that every member of Council has some type of Conflict of Interest in connection with one or more of the organizations listed on the Resolution for water exemptions.
