BOROUGH OF STONE HARBOR COUNTY OF CAPE MAY, NEW JERSEY ORDINANCE NO. 1529

AN ORDINANCE AMENDING CHAPTER 542 (Water and Sewers) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF STONE HARBOR 2005

Chapter 542. Water and Sewers

§ 542-7. Owner's responsibility for water services.

A. The water service line from the meter pit to all outlets in the premises is the sole responsibility of the owner of the premises, and shall be kept in repair or replaced at the owner's expense. All repairs to the water service line from the-meter pit including meter pit equipment to the water main, where negligence is not a factor, shall be the responsibility of the Borough. Application to upgrade Meters, meter boxes, fittings and pipes will be subject to the applicable charges found in § 542-5 and/or § 542-6 hereof.

§ 542-11_**Turnoff charges; final reading charges.** [Amended 3-15-2005 by Ord. No. 1226; 9-2-2008 by Ord. No. 1321; 8-20-2013 by Ord. No. 1431]

A turnoff charge of \$250 will be made if the Utilities Department has effected a temporary turnoff of the water service, either at the request of the customer or because of an emergency, or because the Utilities Department turned off the water service by reason of a violation of any of the sections of this chapter. Each subsequent turnoff will result in the imposition by the Borough of a charge of \$500. Service may only be restored by a licensed New Jersey plumber.

[Amended 2-16-2016 by Ord. No. 1471] Such penalty, if unpaid within thirty days, may be enforced as a fine in the Stone Harbor Municipal Court. The time period for calculation of subsequent offenses shall reset on a calendar year basis.

542-13 Schedule of Water Rates & Fees

<u>(3)</u>

An annual maintenance fee of \$10.00 per meter will be added to the water service bill. This fee will offset any necessary repairs and/or mandatory upgrades to the water service infrastructure within the Borough

§ 542-16_Owner's responsibility for sanitary collection system.

It shall be the sole responsibility of the owner to maintain the entire building sewer in proper operating condition. Restrictions in the building sewer causing limited flow, blockage or discharge of sewage onto any property, into the street, highway or within an easement area, shall be eliminated through arrangements between the property owner and a registered plumber. If the Utilities Department is dispatched to a property and it is determined that the restriction is not within the sewer lateral from the curb to the main a charge of \$250.00 will be imposed upon the property owner. It is illegal for any vent system to discharge sewage onto any property, whether public or private. If such discharges do occur, the cause must be promptly eliminated. Tardy elimination or frequently repeated occasions of such incidences or failure to clean up after such instances shall be a violation of this chapter and shall be reason for the Stone Harbor Board of Health or the Stone Harbor Plumbing Inspector to cause discontinuance of water service and to proceed with necessary arrangements for clean up, etc., and assess the user accordingly.

RE: ESTABLISHING A UNIFORM POLICY WITH RESPECT TO REFUNDS OF CERTAIN RECREATION FEES

WHEREAS, from time to time, the Borough receives a request for a refund of recreation fees; and

WHEREAS, presently all such requests are submitted to Borough Council for consideration and approval; and

WHEREAS, the Borough Council has determined that it would be more expedient to establish a general policy with respect to such matters, which is consistent with other Borough policies regarding refunds or adjustments;

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Stone Harbor, in the County of Cape May and State of New Jersey on this 4th day of September, 2018 as follows:

- 1. The allegations of the preamble are incorporated herein by this reference.
- 2. The following policy is hereby established with respect to requests for a refund of a prepaid recreation fee:
 - (A) Any request for a refund of any fee for a recreation event must be made prior to the scheduled start date for the event. No refund request shall be considered once the event has commenced nor at anytime thereafter.
 - (B) The refund request shall be submitted to the Recreation Director for initial review and determination. If the Recreation Director is satisfied that good cause exists for the refund, theRecreation Director shall submit his determination and recommendation to theBoroughAdministratorand the DirectorofRevenue and Finance fortheir review and concurrence.
 - (C) If all three officials, the Recreation Director, Borough Administrator and Director of Revenue and Finance, concur, then the applicant shall be requested to execute a voucher and follow such other procedures as may be established and upon proper execution, with a copy of the receipt attached, the voucher will be submitted for approval for payment at a regular meeting of Borough Council.
 - (D) A report of all recreation refunds shall be filed with the Borough Clerk at the end of each calendar quarter. Such report shall include the names, addresses, activity registered for, and the amount of refund, together with any additional information that may be requested by Borough Council.

The determination of the Business Administrator, Director of Revenue and Finance and the Recreation Director shall be final and no appeal from that determination shall be taken to the Borough Council.

This Resolution does not apply to beach tags or beach fees, nor is it intended to apply to any event where Borough Ordinance prohibits refunds.

This Resolution shall take effect immediately and shall remain in full force and effect until such time as it may be modified or rescinded by the adoption of a subsequent Resolution.

Whereas, $222 - 81^{st}$ Street LLC #0510-31-006-001 has made a renewal application to the Mayor and Council of the Borough of Stone Harbor, New Jersey, for the Club License for the year beginning July 1, 2018 to June 30, 2019; and,

Whereas the Issuing Authority has found that:

- a) The submitted application forms for renewal are complete in all respects;
- b) The applicants are qualified to be licensed according to all statutory, regulatory and local governmental ABC laws and regulations; and,
- c) The applicants have disclosed and the Issuing Authority has reviewed any additional financing obtained in the previous license term for use in the licensed businesses and there was none; and,

Whereas, no objections have been filed with the Borough Clerk and this body is of the opinion that said application should be granted and a license issued; and,

Whereas, all legal requirements have been complied with and a check in the amount of \$188.00 for the Club License has been attached to the application.

Whereas, the following conditions shall apply:

- A. Seating shall be reserved for members only and their guests;
- B. There shall be a service bar only without adjacent seating. No seating shall be permitted at the bar and drinks shall only be served by waiters or waitresses.
- C. The use shall be as a restaurant only with no catering functions. Accordingly, under no circumstances shall the premises be open for weddings or other "life celebratory" or catered events.
- D. Music shall be limited to live background music only, utilizing small amplifiers of 15 Watts or less.
- E. All live music shall terminate at 10 p.m. Further, any recorded music played through the sound system shall terminate no later than 11 p.m.
- F. The first dinner seating shall occur no earlier than 5:30 p.m. And the last dinner seating shall occur no later than 9 p.m.
- G. The premises shall be utilized as a restaurant seasonally and shall open no earlier than Memorial Day and close no later than the Sunday before Labor Day.
- H. The Licensee shall comply with all Borough Regulations and Ordinances.
- I. Any violation of the above may result in a suspension or termination of the license at the discretion of the governing body.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Stone Harbor, in the County of Cape May and State of New Jersey, that a Club License for the sale of alcoholic beverages shall be signed, issued and delivered to $222-81^{st}$ Street, LLC. That said license shall become effective on July 1, 2018 and be for the one year from said date expiring at the close of business on June 30, 2019 and that said license shall be delivered by the Borough Clerk who is designated as the proper person to sign all licenses on behalf of the Borough Council under Revised General Ordinances 2005, Borough of Stone Harbor, New Jersey.

A RESOLUTION TO AFFIRM THE BOROUGH OF STONE HARBOR'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Borough of Stone Harbor to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law Against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act; and

WHEREAS, the governing body of the Borough of Stone Harbor has determined that certain procedures need to be established to accomplish this policy.

NOW, THEREFORE BE IT ADOPTED on this 4th day of September, 2018 by the Borough Council of the Borough of Stone Harbor that:

Section 1: No official, employee, appointee or volunteer of the Borough of Stone Harbor by whatever title known, or any entity that is in any way a part of the Borough of Stone Harbor shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Borough of Stone Harbor's business or using the facilities or property of the Borough of Stone Harbor.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Borough of Stone Harbor to provide services that otherwise could be performed by the Borough.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Borough Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Borough Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Borough of Stone Harbor as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Borough Administrator shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Borough Administrator shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Borough. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Borough's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Borough of Stone Harbor in order for the public to be made aware of this policy and the Borough's commitment to the implementation and enforcement of this policy.
