BOROUGH OF STONE HARBOR COUNTY OF CAPE MAY, NEW JERSEY ORDINANCE NO 1552

AN ORDINANCE TO AUTHORIZE A PRIVATE SALE OF REAL PROPERTY SITUATE BETWEEN AN EXISTING BULKHEAD AND THE NORTHWESTERLY PROPERTY LINE OF LOTS 539 AND 540, BLOCK 200.03 ON THE TAX MAP OF THE BOROUGH OF STONE HARBOR TO THE CONTIGUOUS LANDOWNER THERETO PURSUANT TO N.J.S.A. 40A:12-13.2

WHEREAS, the Borough of Stone Harbor appears to have an ownership interest in a certain tract or parcel of land having no lot or block designation but being described pursuant to a metes and bounds description prepared by Dante Guzzi Engineering Associates, LLC with dimensions of approximately 79.05° x 4.49° and containing 361.84 sq. feet, hereinafter "Property"; and

WHEREAS, RKH Holdings, LLC (hereinafter "Contiguous Landowner") is the owner of lands contiguous to the Property, said lands being known as Block 200.03, Lots 539 & 540 as shown on the official tax map of the Borough of Stone Harbor and being commonly known as 344 104th Street; and

WHEREAS, Contiguous Landowner desires to purchase the property consisting of approximately 79.05' x 4.49' and containing 361.84 sq. feet landward of the existing bulkhead facing the waterway and has offered to reconstruct approximately 85 linear feet of bulkhead fronting the property and as shown on a survey prepared by Dante Guzzi Engineering Associates dated June 10, 2014 last revision October 29, 2018 and described by a metes and bounds description copies of which are attached hereto and made a part hereof as Exhibit A, with said design and construction to meet the approval of the Borough Engineer; and

WHEREAS, a portion of the Property is without any capital improvements thereon (the existing bulkhead is in disrepair and in need of replacement) and is less than the minimum size required for development under the municipal zoning ordinance; and

WHEREAS, in the judgment of the Governing Body of the Borough of Stone Harbor the said land is of no further use for public purpose and is not needed for public use and should be disposed of in accordance with N.J.S.A. 40A:12-13.2 by sale to the contiguous landowner upon the terms and conditions hereinafter set forth.

NOW THEREFORE, BE IT ORDAINED by the Commissioners of the Borough of Stone Harbor, County of Cape May and State of New Jersey as follows:

SECTION 1. There is hereby authorized for private sale to the Contiguous Landowners, RKH Holdings, LLC, pursuant to the provisions of *N.J.S.A.* 40A:12-13, a tract of parcel of land having no lot or block designation but being described pursuant to a metes and bounds description prepared by Dante Guzzi Engineering Associates, LLC with dimensions of approximately 79.05' x 4.49' and containing 361.84 sq. feet (Schedule A).

SECTION 2: The consideration for this sale shall be a payment to the Borough in the amount of \$25,000.00 and the construction of approximately 85 linear feet of replacement bulkhead in the same location as an existing deteriorated bulkhead fronting the parcel.

SECTION 3: The cost estimate of construction of the bulkhead if performed by the Borough would be approximately \$1,500.00 per linear foot for a total estimated cost of \$127,500.00, which sum meets or exceeds the fair market value of the property.

SECTION 4: An Agreement with the Contiguous Landowner containing the terms herein and as provided by the Borough Solicitor, is hereby authorized and shall be executed by the Mayor of the Borough of Stone Harbor and the Contiguous Property Owner incorporating all essential terms and conditions of the conveyance.

SECTION 5: The Mayor of the Borough of Stone Harbor shall execute and deliver to the Borough Solicitor, a Quit Claim Deed in proper form for recording in accordance with the laws of the State of New Jersey, conveying the Property, which deed is to be held in escrow by the Borough Solicitor pending completion and approval of the bulkhead by the Borough Engineer. Construction shall be performed no later than five (5) months from the passage of this Ordinance.

SECTION 6: Settlement for conveyance of the Property shall occur within thirty (30) days after completion and approval of the constructed bulkhead, settlement to be held at the Borough of Stone Harbor City Hall or such other place as agreed to by the parties.

SECTION 7: All ordinances or parts of ordinances inconsistent with any terms of this ordinance are hereby repealed to the extent of such inconsistency only.

SECTION 8: This ordinance shall take effect upon its final passage and publication as required by law.
